

Statement on directive 2011/65/EU (RoHS 2) and delegated directive 2015/863/EU (RoHS 3) on changes to the Annex II list of substances subject to restrictions

Dear customer,

We would like to assure you that Schukat electronic Vertriebs GmbH regularly contacts its suppliers in order to gather the information necessary to evaluate the products we offer relative to changes in RoHS regulations.

Schukat electronic Vertriebs GmbH proactively monitors the requirements of directive 2011/65/EU (RoHS 2) and delegated directive 2015/863/EU (RoHS 3), on the one hand to make relevant information available to the supply chain reliably and on time and, on the other, to ensure proper management of the regulatory requirements.

Schukat electronic Vertriebs GmbH works closely with its suppliers to gather updated compliance information. On the basis of information already gathered, the majority of our products have already been confirmed as fully compliant.

Details of the status of individual products we distribute are documented in our system and updated as soon as we receive compliance information confirmed by the manufacturer.

RoHS-compliant articles are marked on our website with a green tick. The green tick indicates that the following substances are not used in the article as either a raw material or additive, or that the highest permissible concentrations are not exceeded, as applicable.

- Lead (0.1 %)
- Mercury (0.1 %)
- Cadmium (0.01 %)
- Hexavalent chromium (0.1 %)
- Polybrominated biphenyls (PBB) (0.1 %)
- Polybrominated diphenyl ethers (PBDE) (0.1 %)
- Bis(2-ethylhexyl) phthalate (DEHP) (0,1 %)
- Benzyl butyl phthalate (BBP) (0.1 %)
- Dibutyl phthalate (DBP) (0.1 %)
- Diisobutyl phthalate (DIBP) (0.1%)

Articles are also marked with a green tick if they are covered by an exemption clause in the regulation, or if they involve applications that are exempted from the restrictions.

Articles that are not marked with a green tick are either irrelevant from the RoHS perspective, are non-RoHS-compliant, or are items for which we have received no RoHS information from the manufacturer. RoHS compliance is also indicated on the respective invoice and corresponding delivery note. RoHS compliance status is continuously updated as soon as we receive updated information from our supply chain.

The majority of our suppliers have already confirmed that their products fully meet the requirements of directive 2011/65/EU and delegated directive 2015/863/EU. To the best of our present knowledge, the bulk of both our current inventory and outstanding orders already fulfil the requirements.

Because we operate only as a distributor, we have no direct knowledge of the composition of the components we supply, nor do we have direct knowledge of the substances used in the manufacturing processes. Therefore, please be aware that all information relating to the RoHS status of articles we supply is based on information from the respective manufacturer. Schukat electronic Vertriebs GmbH has no right to make assurances with regard to RoHS. The data we provide is passed on to the best of our knowledge and belief. It is the customer's responsibility to check all information with the manufacturer.

Considering the complexity of the subject and the high number of products and manufacturers involved, we trust you will understand that we are unable to respond to any customer-specific questionnaires and that, as a distributor, we cannot provide any comprehensive, forward-looking or generally applicable endorsements in our name.
